REPORTS

Mr. Robinson reported that recently the CCIU conducted a survey which REPORT OF CHESTER revealed that many people do not know about all the programs provided by the CCIU. This month Mr. Robinson reported on the Migrant Education program in Oxford.

There is an after school program at Penn's Grove for grades 7-12. This is the 21st Century program. Oxford shared a \$400,000 grant with Avon Grove School District for this program. 21st Century is in its fourth year at Oxford and has seventy-six students who participate.

There is an elementary program at Hopewell School for grades K-6. This program is also part of a shared \$300,000 grant with Avon Grove School District and is in year three. This program has eighty students participating.

An Early Intervention class is also offered at Jordan Bank School for children who are pre-Kindergarten and who need special services.

Mr. Tenga reported the Chester County School Boards Legislative Council met on March 28, 2018.

Blake Emanuel of Phoenixville, provided the committee with a recap of House Bill 1308, legislation she is introducing with the assistance of Representative Warren Kampf. The legislation would provide school districts with greater discretion in school suspensions, notifying law enforcement, and mandatory school suspensions/expulsions.

There are efforts underway to provide a menu of options to replace the Keystones as a graduation requirement, such as Senate Bill 660.

Also, a bill is being developed that would require school districts to join a regional health care consortia.

House Bill 1213-This bill would limit a district's right to appeal an assessment.

Senate Bill 383- This bill permits school boards to adopt policies allowing school personnel to have access to firearms on the grounds of a public school. Also, Governor Wolf has formed a School Safety Taskforce.

Senate Bill 521-CPR Instruction: The bill would add a hands-only, 30 minute CPR instruction to the state education curriculum for high school students. First and second considerations are set on the Senate Calendar.

Senate Bill 2-This bill would create ESA's for students in low performing schools is proceeding also.
